Disclaimer regarding illegal ballots versus illegal voters: While this report identifies many illegally cast ballots and the names of ineligible voters in whose name those ballots were cast, it does not allege that those persons necessarily cast the illegal ballots. Determining who cast a ballot, legal or otherwise, particularly as a private, non-governmental organization, proves nearly an impossible feat.

Disclaimer regarding redaction of voter information and research: The public version of this report has redacted appendixes that include voter data and supplemental research. The full version, available to government and law enforcement officials and, on a limited basis, to select individuals and members of the media, has no such redactions.

Summary

This brief is a collection of county clerk responses in relation to the three that we published for Arizona, Pennsylvania, and Wisconsin. One of these was missed in the email records in error as we had Maricopa but had misfiled, whereas the rest are late and new responses. At least one response was due to pressure from the reports made public as evidenced by the county clerk in York, PA. Some clerks may simply be overburdened with work, however, and the slow response time is indicative of their workloads. In any case we thank those clerks for responding, and we ask the public to view the voter rolls and ask those county clerks that have not yet responded to do so and to clean their rolls of questionable voters based on the information we provided.

I can only speak for Maricopa County and our processes. We are not a law enforcement agency – we have no authority to conduct these investigations. If an investigation needs to be conducted, it must be done by a law enforcement agency. If and when an investigation is opened, we cooperate fully with law enforcement

Dear Mr. Davidson, Ms. Lechman, and Ms. Stover,

I am writing to follow up with you in regards to these 23 voters sent your way last month who appear to be illegally registered at and who seem to have voted from P.O. Boxes at the USPS and UPS Store as their residential addresses.

While you may have already removed these voters from your rolls, if you missed them then we are notifying you as these registrations could suggest an intent to hide the nature of their addresses by marking them as a unit, suite, or apartment, or it could simply be a clerical error, or it could be something else like a grandfather clause.

To be clear, these are not the voters' listed mailing addresses, but their listed residential addresses. Many voters we found either had no mailing address or the residential address was the same as the mailing address, which was linked to a nonresidential location - meaning transposition or clerical error would not be possible or explain the reasoning.

We request an investigation into these 23 individuals who appear to have registered and voted from what appear to be P.O. Boxes. If these are indeed fraudulent registrations, we would like at minimum to have the voter rolls cleaned, but ideally be prosecuted if any of those voters intentionally deceived the county registrars and state of Pennsylvania.

Please keep us posted of the results of the investigation into these voters, thank you!

Unfortunately, when registering a voter and putting their address in the SURE system, the system does not verify if the address is a residential or nonresidential address. We process an application, and it puts the voter in the precinct SURE and GIS assign the address too. This is also what happened with
Our Chairman of the Election Board will be reaching out to the Department of State in regards to this system issue, with hope that this issue can be resolved for future Voter Registrations. In the meantime, myself and my staff will be personally checking the residential address the voter provides on their new voter registration application to be sure it is a residential address.
As for we cannot cancel a voter's registration until we have something in writing from the voter themselves saying they have moved. Even if a family member, neighbor, friend, etc notifies us that a voter has moved, we cannot legally remove the voter from the rolls until we have written documentation signed by the voter themselves, saying that they have moved and no longer reside at that address. Dear Snyder County Elections Division,

We are bringing to your attention 5 voters in your county who appear to be illegally registered at and who seem to have voted from P.O. Boxes at the USPS as their residential address. This would suggest an intent to hide the nature of their address by marking it as a unit, suite, or apartment.

Several either had no mailing address or were linked to a P.O. Box - meaning transposition or clerical error would not be possible or explain the reasons.

This is not permitted according to the registration form which reads "Address (not P.O. Box)"

We also reviewed the relevant state voter registration laws to confirm that these voters were not qualified to vote from a P.O. Box under any lawful exemptions before making our determination.

Title 25 [Elections], Chapter 13 [Voter Registration], Subchapter A [Qualifications], Section 1302 [Residence of electors], subsection (B)(1) makes this explicitly clear that one cannot vote using a post office box (or similar like a UPS, FedEx, etc.):

(b) Rules for determination. -- The following apply:

(1) That the place shall be considered the residence of an individual in which habitation is fixed and to which, whenever the individual is absent, the individual has the intention of returning.

Dear Mr. Camacho and Mr. Enright,

The County of York previously received a report of the same list of voters which Look Ahead America forwarded to your attention.

Please note, the County of York and the Elections and Voter Registration Office take election security very seriously. The County and Office routinely receive, review, and investigate allegations of voting irregularities, such as improper or incomplete voter registrations, and the use of business addresses or post office boxes as residential addresses. With one exception, the individuals included on the list you forwarded to our attention had already been reviewed by the County prior to June 16, 2022.

The County of York does not comment on the status of pending or closed investigations.

As a general note of information, any individual that is believed to be involved in intentional election or voter fraud will be referred to the York County District Attorney's Office. If that occurs, the York County District Attorney's Office will determine if sufficient evidence to support a prosecution exists. If an individual is prosecuted for voting or election fraud, certain information about their case will become a matter of public record when criminal charges are filed.

Therefore, please understand that going forward the County of York will not comment on the status of the receipt or review of any specific individuals or of any lists provided by you or others. However, if the District Attorney's Office files charges against any individual, those charges would then become a matter of public record.

Dear Ms. Berger,

I am following up on my email from a month ago regarding a voter in your municipality who appears to have voted as "indefinitely confined" and yet we have evidence that this voter was not confined indefinitely to their residence. Were you able to investigate this case and to make a determination?

We realize that as of August 2021 an audit was performed in most municipalities to update these voters' statuses, however, we are bringing this to your attention so that this voter does not remain grandfathered or a "legacy" indefinitely confined case. Based on the information we have they were not even eliqible in 2020 for indefinitely confined status.

I've attached the case again for your review. We can provide information for this voter if you need additional research on this voter's 2020 status and evidence that they were indeed not indefinitely confined. Please advise, thank you!

Dear Ms. Berger,

We are submitting a voter in your municipality and county that voted in the 2020 General Election as an indefinitely confined voter. We realize that as of August 2021 an audit was performed in most municipalities to update these voters' statuses, however, we are bringing this to your attention so that this voter does not remain grandfathered or a "legacy" indefinitely confined case. Based on the information we have they were not even eligible in 2020 for indefinitely confined status.

Details about the definition of Indefinitely Confined can be found in Wis. Stat. § 6.86(2)

"An elector who is indefinitely confined because of age, physical illness or infirmity or is disabled for an indefinite period may by signing a statement to that effect require that an absentee ballot be sent to the elector automatically for every election. The application form and instructions shall be prescribed by the commission, and furnished upon request to any elector by each municipality. The envelope containing the absentee ballot shall be clearly marked as not forwardable. If any elector is no longer indefinitely confined, the elector shall so notify the municipal clerk."

1,093% more Indefinitely Confined statuses were granted than in 2016, with 169,282 new applications. COVID-19 was not a qualification.

Additionally, the Wisconsin Supreme Court ruled that Wisconsin elections were wrong to assert that voters could claim the status of "indefinitely confined" because of COVID-19. Wisconsin's statutory law states that a person can only classify as indefinitely confined based on his/her age, his/her physical illness (NOT the illness of someone else), or his/her infirmity.

The Court did note that a determination must be made in every single case before throwing out a ballot. Instead, the Court deemed that indefinitely confined ballots must be looked at, and prosecuted, on a case-by-case basis: https://www.wicourts.gov/sc/opinion/DisplayDocument.pdf?content=pdf&seqNo=315283

Our Research Group used a variety of public and semi-publicly available tools to find supplemental evidence of one's residential status.
